- ✓ Know the technologies and uses of cryptographic standards and products.
- ✓ Install and configure network- and host-based security technologies.
- ✓ Describe the standards and products used to enforce security on web and communication technologies.
- ✓ Describe how wireless and remote access security is enforced.
- ✓ Summarize application and coding vulnerabilities and identify development and deployment method designed to mitigate them.

The course is targeted at new to cyber security field, audit, risk, compliance, information security, government and legal professionals with a familiarity of basic Information Technology and Information Systems concepts who are interested in entering the field of cyber security and need to understand the language and principals of cyber security and how it impacts their role.
