Minsk, Republic of Belarus 13-15 November 2019


INFORMATION NOTE

1. INTRODUCTION


This training course aims to introduce participants with the issues of network infrastructure and Internet services protection, as well as with best practices in the appliance of different network and program solutions aimed at the protection of web resources and the network in general. The training will consider possible web service attacks and their consequences (OWASP project and top 10 vulnerabilities), as well as possible variants of protection. The training will cover both theoretical instructions and practice.

8. DETAILS OF ARRIVAL AND TRANSPORT

Participants need to organize their own trips to Minsk and back, as well as during the training seminar.

Taxi service

9. CURRENCY

National currency unit of the Republic of Belarus is Belarusian Ruble (BYN). All payments are executed in the national currency. Currency exchange is executed by banks and currency exchange counters. There is no commission fee.

Credit cards are accepted almost everywhere.

As of 23 October 2019, BYN exchange rate was as following:

1 USD = 2.04 BYN 1 EUR = 2.27 BYN

10. ELECTRICAL APPLIANCES

- A. The voltage in the Republic of Belarus is 220V/50 Hz.
- B. Electricity plugs used are Type C and Type F.

11. LANGUAGES

The training course will be delivered in Russian with simultaneous interpretation into English.

12. SECURITY

Current security situation in the Republic of Belarus is stable.

13. MEDICAL AND HEALTH

Participants are required to have medical insurance. There is a medical station in the building of the BSAC. Emergency care service number – 103.

Drinking water in the Republic of Belarus is safe.

14. WEATHER

The climate of Minsk is moderately continental, significantly influenced by Atlantic maritime air. In April the average daily temperature is about +3°C, the average night temperature is -1°C.
