I am pleased to invite your organisation to participate in a face-to-face training workshop on "Implementation of radio monitoring systems according to ITU-R recommendations" to be held from 2 to 6 September 2019 at the Rohde & Schwarz Regional Learning Center in Singapore. The workshop is part of the ITU Academy training portfolio and will be conducted within the framework of a capacity-building partnership between the International Telecommunication Union (ITU) and Rohde & Schwarz GmbH & Co. (R&S).

The workshop will, among other topics, focus on the following:

- Introduction to spectrum monitoring
- ITU reports, recommendations and handbooks related to monitoring
- Monitoring and radio regulations
- International cooperation in spectrum monitoring
- Monitoring antennas and receivers
- DF and radiolocation basics
- Signal analysis
- Computer-aided spectrum monitoring

## Target group

The workshop targets professional and technical staff from government, operators and regulatory agencies responsible for planning, implementation and operation of spectrum monitoring systems. Participants must have at least three years of professional experience in the area. While the workshop is targeting participants from the Asia-Pacific region, participants from other regions are also welcome.

Although there is no training fee charged for participating in this workshop, all expenses concerning travel, accommodation and meals are expected to be borne by the participants.

## **Fellowship**

Member States eligible to receive ITU fellowships are those listed by the United Nations as developing countries, which also include the least developed countries, small island developing states, landlocked developing countries and countries with economies in transition. I am pleased to inform you that ITU will provide one partial fellowship (covering only daily subsistence allowance in Singapore) per Administration. Member States are encouraged to consider gender balance and the inclusion of participants with disabilities and with specific needs when proposing candidates for fellowships.

Fellowship applications must be authorized by the relevant administration of the ITU Member State and submitted, by e-mail to <a href="mailto:fellowships@itu.int">fellowships@itu.int</a> or by fax: +41 22 730 57 78, no later than 2 August 2019. The final selection of candidates will be carried out by ITU. Forms received after the deadline will not be considered.
