The course is designed to state agents, energy managers and agents in charge of climate change, managers and correspondents for sustainable development, eco-responsibility and project managers, decision-makers in the industrial sector. Other institutions and individuals who are interested in having an overview of carbon footprinting are also welcome to participate in this training program.
